Re: OMA LS dated 5 May 2004 on OMA Dependencies on 3GPP2 Specifications

Thank-you for your Liaison Statement on OMA Dependencies on 3GPP2 Specifications dated 5 May 2004 and the opportunity to provide feedback on the "OMA list of dependencies towards ongoing work in 3GPP2". Based on an initial review of the list provided in the LS, the TSG-S SWG on PMT OMA offers the additional information and comments provided in the table below.

MMS V1.1	No additional comments, at this time.
MMS V1.2	<p>It was noted that your only reference was to X.S0016-200. Please note that the document series also includes X.S0016-310 "MMS MM1 Stage 3 Using OMA/WAP", X.S0016-311 "MMS MM1 Stage 3 Using M-IMAP for Message Submission and Retrieval", X.S0016-340 "MMS MM4 Stage 3 Inter-carrier Interworking", and X.S000-370 "MMS MM7 VASP Interworking Stage 3 Specifications". You may wish to consider enhancing your list of dependencies to include the other documents in the series.</p> <p>The 3GPP2 work item associated with the work is 3GPP2-00078 "Multimedia Messaging Service (MMS) Enhancements".</p>
WI 23	<p>The documents listed are now published specifications so the numbers should be updated to C.S0045-0 and C.S0050-0.</p> <p>The associated 3GPP2 work items are as follows:</p> <p>3GPP2-00004 "Multi-media Message Service (MMS)" relative to C.S0045-0</p> <p>3GPP2-00047 "File and Media Format for Multimedia Services" relative to C.S0050-0.</p>
WI 31	<p>Please provide clarification relative to the phrase "general statements are made on relationship to the 3GPP2 work." Perhaps the work is related to the 3GPP2</p>

	Work Item 3GPP2-00031 “Presence Service” being worked in TSG-X.
WI 43	In addition to X.P0013.2 “IP Multimedia Subsystem (IMS) Stage 2” please update your list to include the other specifications under development; S.P0100 “System Requirements for PoC” and X.P0011 “CDMA2000® Wireless IP Network Specifications.” These specifications are related to the 3GPP2 work item, 3GPP2-00076 “Press to Talk over Cellular (PoC)”
WI 73	Please add the presence service work in the TSG-X series of documents X.P0027-0. The 3GPP2 work item is 3GPP2-00031 “Presence Service.”
WI 74	No additional comments at this time.
WI 76	The 3GPP2 IMS/MMD specifications are contained in the X.S0013-001 through X.S0013-011 series of specifications. The 3GPP2 work item is 3GPP2-00082 “IMS Conferencing.”
WI 86	3GPP2 does not have specification work under development explicitly for Group Management at this time.
