Re: Support of 3GPP2-OMA Work Item dependencies per OMA-TP-2004-0085R1

Dear Peter,

TSG-S WG3 Program Management Team (PMT) has begun preparation of Work Item dependencies between OMA and 3GPP2. In order to assist in that preparation, TSG-S asks assistance from OMA Release Planning and Management in accordance with section three from document OMA-TP-2004-0085R01 (copy attached). In **bold** text below, I have extracted “bullet 3, c)” from the document. TSG-S PMT requests information regarding sub-bullet one in the text. TSG-S PMT is working on sub-bullet two. At this time, we believe that interdependencies on third party organizations can be delayed.

- **Bullet 3, c)**

3GPP2 SC is advised that the Technical Plenary has approved that each of the OMA Working Groups (WGs) shall have responsibility to identify all interdependencies with 3GPP2 on the deliverables that it owns. The OMA WGs shall report such interdependencies to the OMA Release Planning & Management (RP&M) Committee within the framework of OMA Work Programme. The RP&M Committee shall take the responsibility to regularly maintain the information on interdependencies with 3GPP2 in the OMA Work Programme. The RP&M Committee shall also exchange the information on interdependency with the peer organization in 3GPP2.

The information on the interdependencies shall include:-

- **OMA Enabler Releases dependent on 3GPP2 deliverables (identified by OMA WGs)**
- **3GPP2 deliverables dependent on OMA Enabler Releases (identified by 3GPP2)**
- **dependencies on third party organisations**

Please inform TSG-S on any information you currently have and a best estimate of timeframe for sub-bullet one. TSG-S targets completion of the first interdependency list (sub-bullet two) to be shared with OMA RP&M by the November 2004 OMA meeting.
