The International Multimedia Telecommunications Consortium (IMTC), Inc is pleased to invite members of OMA to participate in IMTC's flagship interoperability testing event SuperOp!™ 2013, taking place in Porto, Portugal, from April 26-May 4, 2013.

SuperOp! is a multivendor, multiprotocol, multi-transport interoperability testing event. Participants include multimedia telecommunications equipment producers, protocol stack vendors, network infrastructure vendors, and multimedia and voice endpoint vendors.

The goal of SuperOp! is to allow companies that manufacture multimedia telecommunications equipment to make their products work seamlessly with equipment from other companies. Because of the diversity of equipment, protocols and vendors, it is not practical or economical for a single organization to duplicate such large-scale connectivity in its own test lab. SuperOp! provides a unique opportunity to any company that produces multimedia telecommunications equipment to test their equipment and services at an unprecedented level.

All testing is conducted by IMTC Activity Groups and includes interoperability and interworking tests covering various multimedia implementations ranging from mobile

video telephony to the Telepresence systems. Interoperability testing will include, but will not be limited to the communication technologies such as SIP Video Conferencing, Telepresence/TIP, Packet Switch Streaming (PSS), IMS, VoLTE and others.

SuperOp! is strictly an engineering event intended to provide an open environment for engineers and technical staff to work on and improve interoperability of their products. To facilitate such an open environment, only technical personnel is allowed on the testing floor, and all participants must accept and sign IMTC Rules of Engagement.

SuperOp! participation is generally open to all IMTC members in the good standing and it is one of the benefits of IMTC membership. By the way of this Letter of Invitation, IMTC is pleased to invite OMA members to participate in SuperOp! 2013 at a special discounted non-member rate of \$2,500 (standard non-member SuperOp! fee is \$4,000), plus all other standard charges.
