Dear Kevin,

TSG-S WG3 Program Management Team (PMT) has begun preparation of Work Item dependencies between OMA and 3GPP2. In order to assist in that preparation, TSG-S asks assistance from OMA Requirements WG in accordance with section three from document OMA-TP-2004-0085R01 (copy attached). In **bold** text below, I have extracted “bullet 3, a)” from the document. TSG-S PMT requests the latest versions of the OMA Work Programme plus the three lists.

3GPP2 SC is advised that the Technical Plenary has approved, that on a quarterly basis (or more frequently if required or requested), the current

- **OMA Work Programme**
- **list of approved Work Items**
- **list of draft/approved requirements documents**
- **list of other draft/approved specifications**

consistent with the OMA Openness Policy, shall be communicated to 3GPP2 TSG-S WG3 Program Management Team (PMT) by the OMA Requirements WG. These two groups are now encouraged to execute this approved action.

Additionally, TSG-S PMT has enclosed a draft table which maps terminology per the **bold** text below, also extracted from OMA-TP-2004-0085R01.

- **Bullet 3, b)**

3GPP2 SC is advised that as part of the relationship between 3GPP2 TSG-S WG3 Program Management Team (PMT) and the OMA Requirements WG, the Technical Plenary has approved that in order to facilitate improved understanding between the organisations, a common terminology or mapping of terminology (e.g. RD = Stage 1) shall be created and communicated.

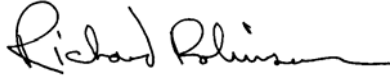
