## 1 Reason for Contribution

In previous REL meetings, a number of members pointed out potential inconsistencies in the rights of Explorer members. Part of this discussion transcends REL, in particular the broader question whether the Explorer membership achieves what it means to achieve. We believe that REL should flag up the issues to the Board and let the Board set a direction for Explorer membership.
